1. Information

The Museum of Cambridge is committed to protecting your privacy and security. This policy explains how and why we use your personal data, to ensure you remain informed and in control of your information.

This Privacy Notice sets out how and why we use the personal data you provide to us, which will differ depending on how you interact with us. We will never sell your personal data, and will only ever share it with organisations we work with under very limited circumstances (e.g. names of volunteers where they are working on a joint project) and if its privacy and security are guaranteed.

Who are we?

We are a small Museum with a big story to tell. Our collections represent Cambridge and Cambridgeshire history and heritage over 300 years, including objects related to everyday life, customs, and traditions of local people, places, and events.

Retention periods

We will only ever collect the information we need. When we ask you to provide your personal information, we will let you know why we are asking and how we will use your data, by directing you towards this notice.

We hold your information for as long as necessary for the purpose it was collected. If you decide not to support the Museum of Cambridge any more or request that we have no further contact with you, we will keep some basic information in order to avoid sending you unwanted communications in the future.

11. Sharing information

We do not disclose personal data to any third parties or external organisations, other than companies carrying out work on our behalf. We retain responsibility for your data and ensure that these organisations only act on our instructions.

Examples of when we share data:

- Sending out our Newsletter
- Email marketing services
- Telephone fundraising agencies working on our behalf
- Wealth screening organisations
- Data cleaning organisations.

We may occasionally need to transfer your personal information overseas. We ensure any transfers of data are secure, in accordance with best practice, and in compliance with the General Data Protection Regulation.

Your data will never be sold or passed to any third party for any other purpose.

12. Legitimate interests

We have a number of legal bases that mean we can use (or 'process') your personal information.

One basis 'Legitimate Interests', which means we can process your personal information if:

- We have a genuine and legitimate reason and;
- We are not harming any of your rights and interests

When we process your personal information for our legitimate interests, we will consider and balance any potential impact on you and your rights under data protection and any other relevant law. Our legitimate business interests do not automatically override your interests.

13. How we keep your information secure

We have implemented security procedures, rules, and technical measures to protect the personal data that we have under our control from:

- Unauthorised access
- Improper use or disclosure
- Unauthorised modification

All our employees and data processors, who have access to and are associated with the processing of personal data, are legally obliged to respect the confidentiality of the personal data that we hold.

14. Your Data Protection Rights

Under data protection laws effective from May 2018, you have rights in relation to your personal data. These rights are:

- The right of access: you have the right to know whether we are processing any of your personal data. If we are, you have the right to access the data and certain information, such as why we are processing the data
- The right of **rectification**: you have the right to ensure that we correct inaccuracies in your personal data that we are processing
- The right of **erasure** (the 'right to be forgotten'): in certain situations, you have the right to ensure that we erase your personal data
- The right to **restriction** of processing: in certain situations, you have the right to ensure that we restrict our processing of your personal data
- The right of data portability: in certain situations, you have the right to receive personal data that you provided to us in a structured, commonly used, and machine-readable format
- The right to **object**: in certain situations, you have the right to object to our processing of your personal data and we are normally obliged to stop processing your data when requested. This right includes the right to object to our processing of your personal data for the purposes of direct marketing
- The right to **complain**: you have the right to make a complaint to the UK Information Commissioner's Office (ICO) about our processing of your data, the exercise of your rights, and other data protection matters
- The right to **withdraw consent**: you have the right at any time to withdraw your consent for us to process your personal data.

These rights are not absolute and may not apply in all situations or in relation to all processing activities.
